# **PROGRAM COORDINATOR**



### Part-Time

Rivers of Steel Heritage Corporation, managers of the Rivers of Steel National Heritage Area, is seeking a part-time program coordinator to manage a new Creative Leadership Program in partnership with the city of Monongahela, Pennsylvania.

#### **POSITION DESCRIPTION**

The program coordinator will work closely with both Rivers of Steel leadership and Monongahela City representatives to assist the project team in crafting a program action plan for the city that accomplishes specific placemaking and connectivity goals set forth by the community. This is a three-year appointment with the potential for extending. The program coordinator's primary responsibility is to manage the Creative Leadership Program (described below). This individual will serve as point of contact for all affiliated parties, coordinate and schedule all necessary committee-planning meetings, and maintain detailed notes on each meeting. The program coordinator will work with the project team and third-party planning consultants to facilitate the program action planning process and provide weekly updates to the arts director. Once planning is complete, the program coordinator will work directly with the Monongahela project team to implement public programs and activities, contract with artists, and collect program data / demographics for reporting purposes. This position will also include occasional project management duties including budgeting, events planning and oversight of contract workers. Occasional weekend hours should be expected.

The program coordinator position will be based in the city of Monongahela, with office and workspace and should expect frequent travel between Monongahela and Rivers of Steel's offices in Homestead, Pennsylvania. All mileage will be reimbursed based on current Government Services Administration (GSA) rates for personally owned vehicles. Personal transportation is required for this position.

The program coordinator reports to the arts director and works collaboratively with fellow arts staff as well as staff from other RSHC departments as appropriate. The program coordinator will perform other duties and responsibilities as required.

- Experience working on community-driven projects and community development.
- Must hold a valid Pennsylvania Driver's License
- Excellent interpersonal, communication, time management and organizational skills.

- Arts and/or events planning experience
- Five years project / program management experience
- Experience managing grant-funded projects and assisting with reporting requirements
- Experience working with stakeholders from varying sectors and backgrounds
- General understanding of and interest in the region's industrial heritage and familiarity with challenges faced by communities in the Monongahela Valley
